### 7 BUSINESS REPORTS FOR DECISION

# 7.1 QUARTERLY BUDGET REPORT - QUARTER ENDING 31 MARCH 2024

#### **EXECUTIVE SUMMARY**

Income shows a forecasted variance of (\$3.179m) and a (\$0.471m) variance for expenditure. The budgeted Operating Result of \$30.298 million surplus will decrease by \$31.939 million to an anticipated Operating Result of \$1.641 million deficit. This decrease is due to the deferral of grant income anticipated to be recognised into 2023/24 the reduced capital grants for flood works and capital work projects carried forward to be completed in 2024/25.

Council's Capital Works program is progressing with an anticipated variation in scheduled works of \$28.141 million. The adopted capital budget for 2023/24 is \$38.691 million and it is expected to decrease to \$10.550 million by 30 June 2024. This decrease is due to the reduction in expected expenditure due to secondary assessment of initial Rapid Impact Assessment of flood works and projects planned for completion in 2024/25.

At 31 March 2024, Council is anticipating an underlying result deficit of \$5.119 million. This gross deficit needs to take into account the advance payments of the Victorian Grants Commission \$3.4m and flood grants \$2.165m that were recognised in 2022/23. This equates to an adjusted underlying result as at 30 June 2024 of \$0.446m surplus.

This Masterplan consolidates the strategic direction of recreation assets within the west of Kerang to better facilitate long-term planning, future investment and development of organised sport and active recreation within Kerang, that benefits the wider municipality as well as visitors and user groups located outside of Gannawarra.

The masterplan includes a site analysis on current conditions of the four identified site locations, demographic assessments to identify future needs and an individual site plan recognising future opportunities and priorities.
