## 21. KEEPING ANIMALS

(1) An owner or occupier of Private Land must not, without a Permit, keep or allow to be kept on any one parcel of land at any time, any more than the number for each type of animal listed in the table below:

Table of Animal Numbers and Types

| Type of Animal | In Flats, <br> Units Or Townhouses | On land up to 1 hectare, excluding Farm Land | On Land greater than 1 hectare and up to 2 hectares | Farm Land |
